PROPOSED

Recommended Guidelines for Clergy Compensation in the Trinity Conference

As pastors care for congregations, congregations care for pastors. Scripture calls the church to provide financial resources sufficient to support and equip pastors to fulfill God's calling (1 Corinthians 9:14; Galatians 6:6; 1 Timothy 5:17-18). Therefore, the Trinity Conference has established recommended minimum standards for the compensation of clergy. Congregations may exceed these standards (and may find it necessary to exceed), but should not fall short of them except in unique circumstances.

CLERGY COMPENSATION PACKAGE

The clergy compensation package may include the following items, which will be discussed in more detail below:

- Base or cash salary,
- housing (either housing allowance or a parsonage)
 - o If a parsonage is provided, churches typically provide a housing allowance to cover utilities and/or other housing expenses.
- health benefits,
- retirement benefits.
- life and disability benefits, and
- other benefits, including professional expense reimbursements and moving expenses.

The compensation package will be developed by the Staff-Parish Relations Committee (SPRC) in conversation with the Finance Committee, the pastor and/or the Presiding Elder. Church leaders should then work with the pastor in the distribution of those funds among the different categories within the total compensation. Each year, the SPRC will recommend the clergy compensation package to the Church Council. After consideration, the Church Council will recommend a compensation package to the Charge/Church Conference for approval.

Matters of Note:

- Churches are required by law to issue W-2's to their appointed or assigned pastors (not 1099s).
- With any compensation matters, it is recommended that church leaders and pastors consult a CPA familiar with church finances and clergy taxes.

Part-Time vs. Full-Time Determination



The vocation of a pastor is a calling, which means that even if a person is employed bivocationally and/or classified as "part-time" for the church, we recognize that someone serving in this capacity is rarely truly "off-the-clock." The following descriptors and numerical increments serve as a guideline for local churches to use in determining whether a pastor is to be considered full-time or part-time. The official determination will_be a joint decision between the pastor, church, and Presiding Elder. This determination is based on two criteria:

- 1. The number of hours and duties in an average week the church expects the pastor to work. This includes all meetings, phone calls, pastoral care, sermon preparation, office hours, and worship services done at the church, in the community or at the pastor's home.
- 2. The compensation of the pastor.

Part-time increments are calculated as ¼, ½, or ¾. In general:

- ¼-time pastors are expected to work less than 15 hours per week. Expected duties include weekly preaching at each church on their charge and providing pastoral care as needed.
- ½-time pastors are expected to work between 15-25 hours per week. Expected duties include weekly preaching at each church on their charge and conducting occasional bible studies, providing pastoral care as needed, and being available at least once a week for office hours.
- ¾-time pastors are expected to work between 25-35 hours per week. Expected duties include weekly preaching at each church on their charge and providing regular bible studies, making regular pastoral visits, tending to the administrative life of the church, and maintaining a presence at least one day weekly in each church/community they serve.
- Full-time pastors are expected to work 35+ hours per week. A person serving full-time is expected to be employed primarily in the work of pastoral ministry to the church or charge they are appointed to and may not be substantially engaged in employment outside of their appointment.

For churches in a multi-point charge, these percentages may be separated by church or combined into one. For benefits purposes, a pastor's part-time increments may be combined to determine eligibility.

Note: At no point can a pastor be appointed to more than full-time.

BASE OR CASH SALARY

The local congregation must determine an appropriate and reasonable base or cash salary for the pastor. This will be based on the church's financial capacity, the local economy, and the pastor's needs. Many churches choose to base this salary portion of the compensation package on a local schoolteacher's pay for someone with commensurate experience and/or the average salary in the community.



Note: One thing to keep in mind is that Social Security treats pastors as self-employed, so they are responsible for paying both portions (employer and employee) of Social Security taxes (FICA). FICA calculations are based on a pastor's cash salary plus all housing allowances and/or the "fair market" rental equivalence of the parsonage a pastor lives in. This reduces the pastor's take-home pay.

If a congregation is unable to provide adequate compensation for their pastor, consideration should be given to joining with another church or churches to increase the base or cash salary to the desired level.

HOUSING

Each congregation will provide full-time pastors with either a suitable, well-maintained parsonage (along with a sufficient housing allowance to cover utilities or other housing expenses) or a sufficient housing allowance that allows the pastor to purchase or rent a home that meets the needs of their family (including all expenses related to housing, such as utilities).

Parsonage Standards

The parsonage should reflect its community while providing sufficient space for the clergy and family. We recommend a parsonage have at least three bedrooms, two bathrooms, and all major appliances (which are kept properly maintained by the church). We further recommend that the church either provide a lawn service for the parsonage or a lawn mower and all necessary supplies for the pastor to maintain the yard.

The parsonage may be unfurnished. However, if the parsonage is furnished, all furniture should be in excellent condition when the pastor moves in. The pastor should also have the option to use his or her own furniture instead of church-owned furniture. If pastors choose to use their own furniture, the church should bear the responsibility of moving and storing the church-owned furniture. Clergy will be responsible for any insurance of their personal items. Clergy will also be responsible for any damage to the parsonage beyond normal wear and tear (including all exterior buildings and ground). Trustees, accompanied by the pastor, are expected to examine the parsonage annually and address any maintenance needs.

Note: If desired, a sample parsonage agreement for the church and the clergy is available from the Presiding Elder upon request.

Housing Expenses

If a parsonage is provided, it is recommended that the church designate some of the compensation as a Housing Allowance to cover utilities and other housing expenses the pastor makes during their time in the parsonage. This Housing Allowance for Housing Expenses should be dispersed evenly throughout the year and receipts are not required for the church.



Note: monies for Housing Expenses are not to cover maintenance, repair, or renovations of the parsonage undertaken by the church, but ordinary expenses such as electricity, water, gas, etc.

Housing Allowance

If no parsonage is provided, churches may work with the pastor to determine the amount of compensation that can be designated as a housing allowance. This housing allowance should be sufficient to purchase or rent an average home in the community where the pastor is expected to live, including mortgage, rent, ordinary utilities and other expenses related to keeping and maintaining a house. A practical starting point for housing allowances for full-time pastors is to use twenty-five percent of the total compensation package, but may be adjusted for the pastor's needs.

HEALTH BENEFITS

Churches with pastors serving full-time are required to ensure that the pastor and the pastor's family (spouse and any eligible dependents) have health benefits. Churches with pastors serving less than full-time may also choose to offer health benefits to the pastor and their family.

Churches with full-time pastors are required to participate in the GMC Health Benefits plan at the GMC's standardized employer contribution rate, unless the pastor requests and receives a waiver from the GMC Benefits Office. Churches may also choose to contribute the pastor's portion of a plan. If so, the additional contribution would be considered taxable income by the IRS and must be reported on the pastor's W-2. It is recommended the church record the extra contribution as "other taxable compensation" to the pastor on the Conference compensation forms.

Churches with $\frac{3}{4}$ time pastors may elect to use the GMC Health Benefits plan. Churches with ½ or ¼ time may not use the GMC Health Benefits plan, but can work out other arrangements to pay for a pastor's health benefits.

If the church is not paying for a pastor's Health Benefits plan directly through the GMC provider, either because the pastor has received a waiver from the GMC health benefits plan or the pastor is ½ or ¼ time, but the church still wants to contribute towards the pastor's chosen health plan (whether it be something the pastor receives through a deduction from their spouse's income, or a Medicare supplement, or another method), it is recommended the church designate a portion of the pastor's compensation as "health benefits reimbursement" up to the amount the pastor is spending for health benefits. If this arrangement is utilized, the "health benefits reimbursement" should be listed as "other taxable compensation" to the pastor on the Conference compensation forms and must be reported as taxable income on the W-2.



RETIREMENT BENEFITS

All clergy who are not in Senior Status and are appointed to at least 50% are eligible to participate in the GMC Covenant Retirement Benefits Program. All clergy who are eligible for retirement benefits but do not wish to receive them may submit a waiver request to the GMC Benefits Officer. If clergy receive a waiver from the GMC retirement benefits program, they may arrange for a separate retirement benefit from the church, if the SPRC agrees.

If a pastor participates in the retirement benefits program, the congregation will pay 5% of the sum of the base or cash salary, housing (including all housing allowances and the fair-market rental value of any parsonage), and other taxable compensation amounts. The congregation will then match the pastor's personal contributions, up to another 5% of compensation. All pastors are encouraged to contribute the full 5% to receive the match.

Additionally, churches with full-time or ¾-time clergy are required to pay for the life and disability insurance benefit provided through the GMC, unless the pastor requests and receives a waiver from the GMC Benefits Office.

PROFESSIONAL EXPENSE REIMBURMENTS

We recommend each church to create a professional expense reimbursement line item in their budget to allow pastors to be reimbursed for expenses designated by the IRS as qualifying business expenses. If two or more pastors are appointed or assigned to a church, it is recommended that each pastor have their own line item for professional expense reimbursement. One benefit to professional expense reimbursements is that they are not considered taxable compensation per IRS guidelines.

Churches are encouraged to create a professional expense reimbursement policy. In lieu of a church policy, the following policy will be used:

- 1. Qualifying professional expenses for reimbursement include: meals where church business is conducted; meals incurred while attending or travelling to and from official church events; mileage paid at the current IRS rate from the church office or the pastor's home to and from places not at the local church where church business is being conducted, including church events, meetings, conferences, pastoral visits, etc.; continuing education or pastoral training expenses, including classes and books, whether online or in-person; electronic equipment or other items deemed necessary for pastoral work by the pastor that is not otherwise provided by the church; and any other expenses defined as reimbursable by the IRS.
- 2. Itemized receipts must be provided by the pastor for all reimbursements.
- 3. Pastors shall not be reimbursed for more than the amount listed in the budget without prior approval from the Finance Committee and/or Church Council.
- 4. Any monies in the budget for professional expense reimbursement which are not spent by the pastor in the financial or calendar year in which they were allocated will not be given to the pastor in cash.



If the pastor requests it, churches may choose to give money directly to a pastor for similar expenses in lieu of creating a professional expense reimbursement system. If so, however, these monies must be reported to the IRS as taxable compensation.

MOVING EXPENSES

We recommend that all reasonable moving expenses for full-time clergy up to \$6000 will be reimbursed by the congregation receiving the pastor. For part-time appointments, churches may choose to reimburse pastors for moving expenses at a mutually-agreed upon amount. If a pastor receives a moving expense reimbursement, the pastor can be expected to provide the congregation with appropriate documentation of the expenses.

If a pastor leaves a congregation but is not moving to a new appointment, the congregation is encouraged to provide financial assistance for that pastor's move, as they are able.

All payments for moving expenses, even if they are given as a direct reimbursement, must be reported on the pastor's W-2 as taxable income above and beyond the base or cash salary listed in the compensation package, as required by the IRS.

TIME OFF: RE-CREATION

A pastor's work is physically, emotionally, and spiritually fatiguing. Without regular rest and renewal, clergy ineffectiveness and burnout are inevitable, doing damage to the pastor, the pastor's family, and the congregation. The SPRC is responsible for assuring that the pastor is taking time away from church responsibilities to re-create. The pastor and the SPRC should be in conversation regarding the use and scheduling of these times.

The SPRC is also responsible for communicating reasonable expectations to the rest of the congregation concerning the pastor's time off. Vacation comes from the Latin vacare, meaning "to be unoccupied". Therefore, when a pastor is on vacation or otherwise utilizing their days off, the congregation should not expect any contact with the pastor except in extreme needs or emergencies. Even during extreme circumstances, the congregation must understand that the pastor may not be reachable by any means until their scheduled return time.

When the pastor chooses to take time off on a Sunday morning, the congregation shall have sufficient funds available for pulpit supply.

WEEKLY DAYS OFF

The congregation should provide the pastor at least two regular days and nights each week free of congregational expectations. While unforeseen circumstances may arise on occasion, they must be the exception.



CONTINUING EDUCATION/SPIRITUAL FORMATION

Each year, the pastor should be provided the time and means for schooling required towards ordination, continuing education for ministry and/or spiritual formation. We recommend at least two weeks of this for all pastors, in addition to vacation/personal time off. Pastors are encouraged to develop an annual growth plan and, upon completion, explain to the SPRC how the pastor and/or the congregation benefit from these experiences.

VACATION/PERSONAL TIME OFF

The amount of Vacation/Personal Time Off given to a pastor is a joint decision between the church and the pastor. We recommend that the time given by the church be based on the total years of a pastor's full-time pastoral ministry, including those in previous denominations.

The recommended minimums for full-time clergy in a calendar year are:

0-5 years experience: 2 weeks, including 2 Sundays; 6-10 years experience: 3 weeks, including 3 Sundays; 11-15 years experience: 4 weeks, including 4 Sundays; 16-25 years experience: 5 weeks, including 5 Sundays; more tha 25 years experience: 6 weeks, including 6 Sundays.

The recommended minimums for clergy who are less than full-time are at least 2 weeks of vacation/personal time off each calendar year, including 2 Sundays.

SABBATICALS

When a pastor has served six consecutive years in a same full-time appointment, the congregation will encourage the pastor to take a sabbatical as provided by the TBDD ¶417.3.

MATERNITY/PATERNITY LEAVE

When a pastor is expecting to receive a new child into their household by birth or adoption, churches are required to provide for maternity and paternity leave for the pastor. The requirements and expectations are addressed in the TBDD ¶417.6.

BYLAWS OF TRINITY ANNUAL CONFERENCE OF THE GLOBAL METHODIST CHURCH

A Texas Nonprofit Corporation

ARTICLE I ORGANIZATIONAL INFORMATION

A. Organization and Name.

The Trinity Annual Conference of the Global Methodist Church (the "Trinity Conference") is organized in accordance with the Chapter 22, Nonprofit Corporations of Title 2, Corporations, of the Business Organizational Code of the State of Texas, as amended from time to time (the "Texas Business Code").

B. Registered Agent and Office.

- 1. Agent & Office. The registered office and registered agent shall be as set forth in the Trinity Conference's Certificate of Formation on file with the Office of the Secretary of State of Texas, as amended from time to time. The registered office and/or the registered agent may be changed by resolution of the Trinity Conference's Board of Directors, subject to submission and acceptance of the appropriate filing(s) with the Office of the Texas Secretary of State.
- 2. Additional Offices. In addition, the Trinity Conference may also have other offices at such places, within or without the State of Texas, as the Board of Directors may designate, or as the business of the Trinity Conference may require or as may be desirable.

C. Affiliation and Statement of Faith.

- 1. Statement of Faith. As a member of the Global Methodist Church (the "GMC"), the Trinity Conference hereby affirms the doctrines, principles and guidelines of the Transitional Book of Doctrines and Discipline of the GMC, as such may be amended, supplemented, modified, replaced, or renamed from time to time (the "Transitional Book") and hereby incorporates the Transitional Book as its Statement of Faith.
- 2. Binding Nature. While the Transitional Book does not exhaust the extent of the Trinity Conference's faith, it does accurately represent the teachings of the Bible and, therefore, is binding upon all members. All literature, whether print or electronic, used in the Trinity Conference shall agree with the Transitional Book.

D. **Non-Profit Status**

1. Statement of Purpose. The Trinity Conference is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as may be amended, modified, or revised (or the corresponding provision of any future United States Internal Revenue law), hereinafter referred to as the "501 (c) (3) Provisions", including, without limitation:



- a. proclaiming of the Gospel of the Lord Jesus Christ;
- b. establishing and maintaining of religious worship;
- c. education of believers in a manner consistent with the requirements of Holy Scripture;
- d. maintaining of missionary activities in the United States and any foreign country;
- e. leasing or renting of space in its facilities to third parties, to the extent, and only to the extent that, such rentals or leases do not jeopardize the Trinity Conference's status under the 501 (c) (3) Provisions.

2. Conflicts of Interest.

- a. Net Earnings. No part of the net earnings of the Trinity Conference shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the Trinity Conference shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the Trinity Conference.
- b. *Dividends*. The Trinity Conference shall not pay a dividend to the Trinity Conference's members, directors, or officers, if any except to the extent permitted under the Texas Business Code.
- 3. <u>Political Activities</u>. No substantial part of the activities of the Trinity Conference shall be the carrying on of propaganda or otherwise attempting to influence legislation. The Trinity Conference shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.
- 4. <u>Disposition of Assets</u>. Upon the dissolution of the Trinity Conference, after paying or making provision for payment of all its liabilities, the Trinity Conference shall dispose of all of its remaining assets to such organization or organizations formed and operated exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under the Section 501 (c) (3) Provisions. Any action to dissolve the Trinity Conference must be approved by a two-thirds (2/3) vote of the Board of Directors, or their established Management Committee present at a meeting called to specifically consider such action, for which meeting written notice has been issued to all Directors or Committee Members in accordance with the provisions of these bylaws.
- 5. Exempt Activities. Notwithstanding any other provisions of these bylaws, the Trinity Conference shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under the Section 501 (c) (3) Provisions or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 as such may be amended, altered, modified or replaced by the responding provisions of any future United States Internal Revenue law.



ARTICLE II MEMBERSHIP

The Trinity Conference has no members.

ARTICLE III MANAGEMENT

A. Board of Directors.

Management of the Trinity Conference, including, without limitation, the day-to-day, financial, spiritual, and governing affairs of the Trinity Conference is vested exclusively in its Board of Directors, or its equivalent governing body, if applicable, and as provided herein and the Trinity Conference's then current Certificate of Formation.

B. Management Committee.

The Board of Directors may, by resolution pursuant to Section 22.218 of the Texas Business Organizations Code, Title 2 Corporations, Chapter 22, Nonprofit Corporations:

- 1. elect to establish a management committee to be responsible for the day-to-day management of the corporation;
- 2. select a title for the committee, which may or may not include management committee; and
- 3. delegate some or all authority of the Board in the management of the corporation, provided, however, the following sets of authority shall be retained by the Board:
 - a. Fundamental Actions. A fundamental action consisting of the following (each a "Fundamental Action" and collectively, the "Fundamental Actions":
 - i an amendment of the Certificate of Formation;
 - ii voluntary winding up under Chapter 11 of the bankruptcy code
 - iii revocation of a voluntary decision to wind up under Texas Business Code §11.151
 - iv cancellation of an event requiring winding up under Texas Business Code;
 - v a restatement under §11.202 of the Texas Business Code
 - vi a distribution plan under §22.305 of the Texas Business Code;
 - vii a plan of merger under Subchapter F of the Texas Business Code;
 - viii a sale of all or substantially all of the assets of the corporation;
 - ix a plan of conversion under subchapter F of the Texas Business Code; and
 - x a plan of exchange under Subchapter F of the Texas Business Code.



- b. Fundamental Business Transactions. A fundamental business transaction consisting of those action items and/or approval identified in Subchapter F of the Texas Business Code (each a "Fundamental Business Transaction" and collectively, the "Fundamental Business Transactions") and generally include:
 - i approvals of mergers,
 - ii sales of all or substantially all of the assets,
 - iii execution of a pledge, mortgage, deed of trust or trust indenture and
 - iv approval of a conversion or exchange.

ARTICLE IV ANNUAL CONFERENCE

A. Organization & Annual Conference

The Trinity Conference is formed for the purpose of connecting clergy and laity for shared ministry and accountability across a geographical region. The voting membership shall be composed of active deacons, elders, senior clergy, and lay members as provided in the Transitional Book, as amended, modified, supplemented, revised, or replaced. The annual conference, inclusive of any Special Session(s), may be held by electronic or other digital means, as directed by the Transitional Book. The bishop assigned shall preside over the annual conference or, in case of inability, shall arrange for another bishop to preside.

B. Powers, Duties, Boards and Committees.

The annual conference is charged with the responsibilities identified in the Transitional Book and may create those boards and committees authorized in the Transitional Book.

C. Transitional Provisions.

The annual conference should establish a funding percentage for its local churches to support the work of the Trinity Conference, provided, however, efforts should be made to minimize Trinity Conference funding in order to allow maximum resources to remain in local churches, all pursuant to the Transitional Book.

ARTICLE V BOARD OF DIRECTORS

A. General Powers.

The business affairs of the Trinity Conference shall be exclusively managed by a Board of Directors; provided, however, the Board of Directors may, pursuant to Section 22.217 of the Texas Business Code and Paragraph J. of this Article V, by resolution adopted by the majority of the Directors in office, designate one or more committees to have and exercise the authority of the Board in the management of the corporation to the extent established pursuant to said resolution. Any committee so established may be composed entirely of persons who are not directors of the corporation.



B. Composition.

The Board of Directors shall initially consist of four (4) directors indicated in the original Certificate of Formation. Except to the extent delegated to a Management Committee established pursuant to Section 22.217 of the Texas Business Code, additional directors may be elected by the then current Board of Directors to term of three (3) years or until a successor has been elected and qualified and the number of directors may be increased or decreased by a majority vote of the then current Directors.

C. Quorum.

A majority of directors, or Management Committee members, if applicable, shall constitute a quorum.

D. Term.

The directors shall be divided into two (2) equally divided groups to provide for staggered terms with one group being elected in any one year except any initial year of change in the number of directors. In any initial year of change, the directors then elected shall be assigned to a group to ensure equally divided groups. There is no limit to the number of terms that a director may serve.

E. Regular Meeting.

The Board of Directors shall meet after the election for the purpose of appointing a Chair, Vice Chair and Secretary and for transacting such other business as may be deemed appropriate. The Board of Directors may provide, by resolution, for additional regular meetings without notice other than the notice provided by the resolution.

F. Special Meetings

Special meetings may be requested by the President Pro Tempore or equivalent officer referred to by a different title (the "**President Pro Tempore**"), Executive Officer, Operating Officer, Vice President, Secretary or any three (3) directors by providing five (5) days' prior written notice. Minutes of the meeting shall be sent to the Board of Directors within two (2) weeks after the meeting.

G. Procedures

The vote of a majority of the directors, or Management Committee members, if applicable, attending a properly called meeting at which a quorum is present shall be the act of the Board of Directors unless the vote of greater number is required by law or by these bylaws for a particular resolution. A director or Management Committee member of the organization who is present at a meeting of the Board of Directors at which action on any corporate matter is taken shall be presumed to have assented to the action unless their dissent shall be entered in the minutes of the meeting. The Board, or Management Committee, if applicable, shall keep written minutes of its proceedings in it permanent records.



H. Informal Action

Any action required to be taken at a meeting of the Board of Directors or Management Committee, if applicable may be taken without a meeting if a consent in writing setting forth the action so taken is signed by all of the members of the Board of Directors, or the Management Committee, if applicable.

I. Removal and/or Vacancies Prior to Expiration of Elected Term.

- 1. <u>Directors</u>. A director shall be subject to removal, with or without cause, at a meeting called for that purpose. Any vacancy that occurs on the Board of Directors, whether by death, resignation, removal or any other cause (other than expiration of the term of appointment), may be filled by the Management Committee, if established by the Board, or, in the event the Board has not established a Management Committee, then the remaining directors of the Board of Directors. A director elected to fill a vacancy shall serve the remaining term of their predecessor or until a successor has been elected and qualified.
- 2. Management Committee Members. A member of the Management Committee shall be subject to removal, with or without cause, at a meeting called for that purpose. Any vacancy that occurs on the Management Committee, whether by death, resignation, removal, or any other cause (other than expiration of the term of appointment), may be filled by the remaining members of the Management Committee. A member of the Management Committee elected to fill a vacancy shall serve the remaining term of their predecessor or until a successor has been elected and qualified.

J. Vacancies Due to Expiration of Elected or Appointed Term.

A member of the Board of Directors or the Management Committee exiting the Board or Management Committee, as applicable, due to the expiration of their elected or appointed term, as applicable, shall be replaced by the voting members of the Annual Conference pursuant to the provisions of Article IV of these Bylaws.

K. Board Committees.

To the extent permitted by law, the Board of Directors may appoint from its members a committee or committees, temporary or permanent, Management or otherwise, and designate the duties, powers, and authorities of such committee, except as limited by the Certificate of Formation, these Bylaws, or the Texas Business Code. The designation of such committees and the delegation thereto of authority shall not operate to relieve the directors of any responsibility imposed by law. Each member of a committee shall continue as such until a successor is appointed in the committee member's stead, unless the committee shall be sooner terminated, or unless such member be removed from such committee. One member of each committee shall be appointed chairman by the person, or persons authorized to appoint the members thereof. Vacancies in the membership of any committee may be filled by appointments made in the same manner as provided in the case of the original appointments. Unless otherwise provided in the resolution designating a committee, a majority of the whole committee shall constitute a quorum and the act of a majority of the members present at a meeting at which a quorum is present



shall be the act of the committee. Each committee may adopt rules for its own government not inconsistent with these Bylaws or with rules adopted by the Board of Directors.

L. Action by Board of Directors or Committee without a Meeting.

Any action required by the Texas Business Code to be taken at a meeting of the Board of Directors or any committee, may be taken without a meeting if a consent in writing, setting forth the action to be taken, shall be signed by all of the members of the Board or committee, as the case may be. Such consent shall have the same force and effect as a unanimous vote. Prompt notice of the taking of any action by the Board of Directors or a committee without a meeting by less than unanimous written consent shall be given to all members or committee members who did not consent in writing to the action.

M. Place of Meeting.

The Board of Directors, or Management Committee, if applicable, may designate any place, either within or without the State of Texas, as the place of meeting for any annual meeting or for any special meeting. If no designation is made or if a special meeting be otherwise called, the place of meeting shall be the registered office of the Trinity Conference in the State of Texas, but if all of the members shall meet at any time and place either within or without the State of Texas and consent to the holding of a meeting, such meeting shall be valid without call or notice, and any corporate action may be taken at such meeting.

ARTICLE VI OFFICERS

A. Number of Officers.

The officers of a Trinity Conference shall consist of a President Pro Tempore, which shall serve as the President of the Corporation, a Chief Executive Officer, a Chief Operating Officer, a Corporate Secretary, a Treasurer and may also consist of one or more vice-presidents and such other officers and assistant officers as may be deemed necessary. Any two or more offices may be held by the same person, except the offices of president and secretary; provided, however, a committee duly designated may perform the functions of any officer and the functions of any two or more officers may be performed by a single committee, including the functions of both president and secretary.

B. Designation of Corporate Officers.

It is specifically recognized that the office of President will be initially filed by the President Pro Tempore until the election of the Conference Superintendent. The Board of Directors, or the Management Committee, if applicable. may, from time to time, as deemed appropriate, appoint other Trinity Conference officers, subject to a majority confirming vote by preset voting Trinity Conference members at any regular or special Trinity Conference administrative meeting.



C. Appointment of Officers and Term of Office.

All officers (other than members of the clergy) shall be appointed annually by the Board of Directors, or the Management Committee, if applicable, at their regular annual meeting to serve for that ensuing year and shall serve until a successor may be appointed and qualified. All officers who are members of the clergy shall be appointed by the Bishop to serve until a successor may be appointed.

D. Removal of Officers & Vacancies.

Any elected officer that is not a member of the clergy may be removed by the Board of Directors, or the Management Committee, if applicable, by two thirds vote of the Directors or members of the Management Committee, if applicable, whenever in their judgment the best interests of the Trinity Conference will be served thereby. A vacancy in any office because of death, resignation, removal, disqualification or otherwise of an officer that is not a member of the clergy, may be filled by the Board of Directors, or Management Committee, if applicable, for the unexpired portion of the term. Any appointed officer that is a member of the clergy may be removed by the Bishop, whenever in his or her judgment the best interests of the Trinity Conference will be served thereby. A vacancy in any office because of death, resignation, removal, disqualification or otherwise of an officer that is a member of the clergy, may be filled by the Bishop for the unexpired portion of the term.

E. Powers of Officers.

- 1. Powers & Duties. Each officer shall have, subject to these Bylaws, in addition to the duties and powers specifically set forth herein, such powers and duties as are commonly incident to that office and such duties and powers as the Board of Directors, or Management Committee, if applicable, shall from time to time designate. All officers shall perform their duties subject to the directions and under the supervision of the Board of Directors or Management Committee, if applicable, The President may secure the fidelity of any and all officers by bond or otherwise.
- 2. Reliance. In the discharge of a duty imposed or power conferred on an officer of a Trinity Conference, the officer may in good faith and with ordinary care rely on information, opinions, reports, or statements, including financial statements and other financial data, concerning the Conference or another person, that were prepared or presented by: (1) one or more other officers or employees of the Conference, including members of the Board of Directors or Management Committee, if applicable; or (2) legal counsel, public accountants, or other persons as to matters the officer reasonably believes are within the person's professional or expert competence. An officer is not relying in good faith within the meaning of this section if the officer has knowledge concerning the matter in question that makes reliance otherwise permitted by this subsection unwarranted.



F. President.

- <u>Duties</u>. The President shall see that all orders and resolutions of the Board, or Management Committee, if applicable, are carried out, subject however, to the right of the Directors or Management Committee, if applicable, to delegate specific powers, except such as may be by statute exclusively conferred on the President, to any other officers of the Trinity Conference.
- 2. <u>Execution Authority</u>. The President or any Vice-President shall execute bonds, mortgages and other instruments in the name of the Trinity Conference.
- 3. <u>Ex-Officio Member</u>. The President, or his or her designee, shall be ex-officio a member of all standing committees, unless otherwise specified by the Transitional Book.
- 4. <u>Annual Report</u>. The President shall submit a report of the operations of the Trinity Conference for the year to the directors at their annual meeting.

G. Absence or Disability.

The Vice Chair or Operations Officer, shall, in the absence or disability of the President, perform the duties and exercise the powers of the President, and they shall perform such other duties as the Board or Management Committee, if applicable, prescribes.

H. Secretary and Assistant Secretaries.

- <u>Secretary</u>. The Secretary shall attend all meetings of the Board and shall record all
 votes and the minutes of all proceedings and shall perform like duties for the standing
 committees when required. The Secretary shall give or cause to be given notice of all
 meetings of the Board and shall perform such other duties as may be prescribed by
 the Board.
- Assistant Secretary. The Assistant Secretaries shall, in the absence or disability of the Secretary, perform the duties and exercise the powers of the Secretary, and they shall perform such other duties as the Board or Management Committee shall prescribe.
- 3. <u>Absence</u>. In the absence of the Secretary or an Assistant Secretary, the minutes of all meetings of the board shall be recorded by such person as shall be designated by the President or by the directors or Management Committee members as applicable.

I. Treasurer and Assistant Treasurers.

 Funds Custody. The Treasurer shall have the custody of the corporate funds and securities and shall keep full and accurate accounts of receipts and disbursements in books belonging to the Trinity Conference and shall deposit all moneys and other valuable effects in the name and to the credit of the Trinity Conference in such depositories as may be designated by the Board or Management Committee, if applicable.



- 2. Funds Disbursement. The Treasurer shall disburse the funds of the Trinity Conference as may be ordered by the Board or Management Committee, if applicable, taking proper vouchers for such disbursements. The Treasurer shall keep and maintain the Trinity Conference's books of account and shall render to the President and directors an account of all of the Treasurer's transactions and of the financial condition of the Trinity Conference and exhibit the books, records and accounts to the President or directors at any time. The Treasurer shall disburse funds for capital expenditures as authorized by the Board or Management Committee, if applicable, and in accordance with the orders of the President, and present to the President's attention any requests for disbursing funds if in the judgment of the Treasurer any such request is not properly authorized. The Treasurer shall perform such other duties as may be directed by the Board, Management Committee, if applicable or by the President.
- 3. <u>Bond</u>. If required by the Board or Management Committee, if applicable, the Treasurer shall give the Trinity Conference a bond in such sum and with such surety or sureties as shall be satisfactory to the Board or Management Committee, if applicable, for the faithful performance of the duties of the office and for the restoration to the Trinity Conference, in case of death, resignation, retirement or removal from office, of all books, papers, vouchers, money and other property of whatever kind in the incumbent's possession or under the incumbent's control belonging to the Trinity Conference.

ARTICLE VII TRINITY CONFERENCE PROPERTY

A. Ownership and Control.

The ownership and control of the real and personal property of the Trinity Conference shall be vested in the Trinity Conference and shall not be subject to the control of any other person as defined in Section 1.002(69-b) of the Texas Business Code. The power to convey any of the real property is vested in the Board or Management Committee, if applicable.

B. Trusts.

The Trinity Conference is authorized to hold real and personal property in trust and serve as a trustee for any real or personal property which the owner thereof establishes a trust under law and for which the Trinity Conference accepts said trustee service. The Trinity Conference may authorize the Board or Management Committee, if applicable to manage or dispose of any trust property provided that said management or disposition is conducted in accordance with the terms of the trust.



VIII

INDEMNIFICATION AND INSURANCE

A. Indemnification.

The Trinity Conference shall have the full power to indemnify and advance or reimburse expenses pursuant to the provisions of the Texas Business Code to any person entitled to indemnification under the provisions of the Texas Business Code.

B. Insurance.

The Trinity Conference may purchase and maintain insurance or another arrangement on behalf of any person who is or was a director, officer, employee, or agent of the Trinity Conference or who is or was serving at the request of the Trinity Conference as a director, officer, partner, venturer, proprietor, trustee, employee, agent, or similar functionary of another foreign or domestic Trinity Conference, employee benefit plan, other enterprise, or other entity, against any liability asserted against him or her and incurred by him or her in such a capacity or arising out of his or her status as such a person, whether or not the Trinity Conference would have the power to indemnify him or her against that liability. If the insurance or other arrangement is with a person or entity that is not regularly engaged in the business of providing insurance coverage, the insurance or arrangement may provide for payment of a liability with respect to which the Trinity Conference would not have the power to indemnify the person only if including coverage for the additional liability has been approved by the Board or Management Committee, if applicable, of the Trinity Conference. Without limiting the power of the Trinity Conference to procure or maintain any kind of insurance or other arrangement, the Trinity Conference may, for the benefit of persons indemnified by the Trinity Conference, (1) create a trust fund; (2) establish any form of self-insurance; (3) secure its indemnity obligation by grant of a security interest or other lien on the assets of the Trinity Conference; or (4) establish a letter of credit, guaranty, or surety arrangement. The insurance or other arrangement may be procured, maintained, or established within the Trinity Conference or with any insurer or other person deemed appropriate by the Board of Directors regardless of whether all or part of the stock or other securities of the insurer or other person are owned in whole or part by the Trinity Conference. In the absence of fraud, the judgment of the Board or Management Committee, if applicable, as to the terms and conditions of the insurance or other arrangement and the identity of the insurer or other person participating in an arrangement shall be conclusive and the insurance or arrangement shall not be voidable and shall not subject the directors approving the insurance or arrangement to liability, on any ground, regardless of whether directors participating in the approval are beneficiaries of the insurance or arrangement.



ARTICLE IX MISCELLANEOUS

A. Waiver of Notice.

Whenever any notice is required to be given to a director of the Trinity Conference under the provisions of the Texas Business Organizations Code, the Certificate of Formation, or these Bylaws, a waiver thereof in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be equivalent to the giving of such notice.

B. Trinity Conference Meetings by Telephone, Electronic or Remote Communications.

Subject to the provisions required or permitted by the Texas Business Code and these Bylaws for notice of meetings, members of the Board of Directors, or members of any committee may participate in and hold a meeting of such members, board, or committee by means of: (1) Trinity Conference telephone or similar communications equipment by which all persons participating in the meeting can communicate with each other; or (2) another suitable electronic communications system, including videoconferencing technology or the Internet. Participation in a meeting pursuant to this section shall constitute presence in person at such meeting, except where a person participates in the meeting for the express purpose of objecting to the transaction of any business on the ground that the meeting is not lawfully called or convened.

C. Seal.

There shall be no official seal for the corporation and no seal shall be required for the validity of any documents involving the corporation. Accordingly, the lack of the corporate seal shall not affect an otherwise valid contract or other instrument executed by the Trinity Conference.

D. Contracts.

The Board or Management Committee, if applicable, may authorize any officer or officers, agent, or agents of the Trinity Conference, in addition to the officers so authorized by these Bylaws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Trinity Conference, and such authority may be general or confined to specific instances.

E. Checks, Drafts, etc.

All checks, drafts, or other instruments for payment of money or notes of the Trinity Conference shall be signed by such officer or officers or such other person or persons as shall be determined from time to time by resolution of the Board or Management Committee, if applicable. The members of the Board and Management Committee, if applicable are hereby so determined and designated.



F. Deposit.

All funds of the Trinity Conference shall be deposited from time to time to the credit of the Trinity Conference in such banks, trust companies, or other depositories as the Board or Management Committee, if applicable may select.

G. Gifts.

The Board of Directors may accept on behalf of the Trinity Conference any contribution, gift, bequest, or devise for any general or special purposes of the Trinity Conference.

Н. **Books and Records.**

The Trinity Conference shall keep current, correct and complete books, records of account historical files; keep minutes of the proceedings of all meetings of the Board, Management Committee, if applicable, and other committees, if any; in either written paper form or maintained by or on behalf of the Trinity Conference on, or by means of, an information storage device or method or one or more electronic data systems, provided that any books, records and minutes so maintained can be converted into written paper form within a reasonable time.

I. Financial Records and Annual Reports.

The Trinity Conference shall maintain current true and accurate financial records with full and correct entries made with respect to all financial transactions of the Trinity Conference, including all income and expenditures, in accordance with generally accepted accounting practices. All records, books, and annual reports (if required by law) of the financial activity of the Trinity Conference shall be kept at the registered office or principal office of the Trinity Conference in this state for at least three (3) years after the closing of each fiscal year and shall be available to the members, or their designated representative, for inspection and copying there during normal business hours. The Trinity Conference may charge for the reasonable expense of preparing a copy of a record or report.

J. Fiscal Year.

The fiscal year of the Trinity Conference shall be the calendar year unless otherwise determined by the Board or Management Committee, if applicable.

K. Choice of Forum.

These bylaws are governed by and shall be construed in accordance with the law of the State of Texas, excluding any conflict-of-laws rule or principle, that might refer the governance or the construction of these bylaws to the law of another jurisdiction.

Transitional Book. L.

Any provisions of the Transitional Book regarding the governance of the Trinity Conference shall not control over the provisions of these Bylaws unless otherwise allowed herein but may be considered as an alternative to the provisions herein provided said provisions are compliant with Texas Law and the Certificate of Formation.



М. Pronouns and Headings.

All personal pronouns used in these Bylaws shall include the other gender whether used in masculine or feminine, and the singular shall include the plural whenever and as often as may be appropriate. All headings herein are for convenience only and neither limit nor amplify the provisions of these Bylaws.

N. Invalid Provisions.

If any one or more of the provisions of these Bylaws, or the applicability of any such provision to a specific situation, shall be held invalid or unenforceable, such provision shall be modified to the minimum extent necessary to make it or its application valid and enforceable, and the validity and enforceability of all other provisions of these Bylaws and all other applications of any such provision shall not be affected thereby.

In the event of a conflict among (i) the Certificate of Formation, (ii) these Bylaws, (iii) the Transitional Book, and (iv) the Texas Business Code, the following order will prevail and control:

The Texas Business Code;

The Transitional Book:

The Certificate of Formation; and

The Bylaws.

ARTICLE X **AMENDMENT OF BYLAWS**

The Board or Management Committee, if applicable, by a majority vote may alter, amend, or repeal these Bylaws, or adopt new Bylaws at any regular or special meeting, upon notice given at least ten (10) days prior to the meeting and stating the purpose thereof, provided that any amendment is compliant with the Certificate of Formation and the Texas Business Code.
