

# MINUTES OF SPECIAL SESSION OF THE TRINITY ANNUAL CONFERENCE

---



**September 6, 2025**

**Meeting via Zoom Webinar**

**Bishop Scott Jones, Presiding Bishop**

**Rev. Clark Atkins, Recording Secretary**

Conference called to order by Bishop Scott Jones at 9:02 am on September 6, 2025.

Devotional given by Bishop Scott Jones from Ezekiel 34:1-6. Devotional ended with prayer.

Bishop Jones presented rules to be voted upon and asked if there were any objections to the presented rules. No objection, so the rules were adopted as presented.

Rev. Jason Burnham reviewed instructions on how to use vpoll to elect delegates for the 2026 General Conference.

Bishop Jones presented vote to elect Rev. Clark Atkins as the conference recording secretary and asked if there were any objections. No objections were made, so Rev. Atkins was elected as the conference recording secretary.

Bishop Jones presided over practice ballots for laity and clergy practice.

- Lay practice vote on ice cream flavors.
- Clergy practice vote on candy bars.

Bishop Jones reviewed the voting rules, and he explained that ballots will alternate between clergy and lay delegates. Then Bishop Jones also explained that the exact number of delegates allotted to the Trinity Conference will be established in January 2026, because new annual conferences are still being formed around the world. However, based on current projections, the Trinity Conference believes that electing 13 delegates and 7 alternate/reserve clergy and lay delegates, the Trinity Conference will have a sufficient number of lay and clergy representatives to General Conference 2026.

Bishop Jones prayed before ballots.

### **Bishop Jones called for Lay Ballot 1**

124 votes were cast with 63 being necessary for election.

13 lay delegates were elected on Ballot 1 as follow:

### **Bishop Jones called for Clergy Ballot 1**

162 votes were cast with 82 being necessary for election.

11 clergy delegates were elected on Ballot 1 as follow:

**Bishop Jones called for Lay Alternates/Reserves Ballot 1**

Technical challenges occurred resulting in Lay Alternates/Reserves Ballot 1 being invalidated.

**Bishop Jones called for Lay Alternates/Reserves Ballot 2**

123 Votes were cast with 62 being necessary for election.

Seven alternate and reserve lay delegates were elected on Ballot 2 as follow:

**Bishop Jones called for Clergy Ballot 2**

165 votes were cast with 83 being necessary for election.

**Bishop Jones called for Clergy Ballot 3**

162 votes were cast with 82 being necessary for election.

**Bishop Jones called for Clergy Ballot 4**

162 votes were cast with 82 being necessary for election.

Two clergy delegates were elected on Ballot 4 as follow:

This completed the delegation for clergy.

**Bishop Jones called for Clergy Alternate/Reserve Ballot 1**

164 votes were cast with 83 being necessary for election.

Four clergy alternate/reserve delegates were elected on Ballot 1 as follow:

**Bishop Jones called for Clergy Alternate/Reserve Ballot 2**

159 votes were cast with 80 being necessary for election.

**Bishop Jones called for Clergy Alternate/Reserve Ballot 3**

159 votes were cast with 80 being necessary for election.

Two clergy alternate/reserve delegates were elected on Ballot 3 as follow:

This completed the clergy alternate/reserve delegation.

This completed the clergy balloting.

Bishop Jones reminded participants that the exact number of lay and clergy delegates allotted to the Trinity Conference has not yet been determined.

Bishop Jones thanked all of those who submitted their names for the election and everyone who was elected as delegates and alternate delegates.

Bishop Jones offered a closing prayer.

Bishop Jones adjourned the Conference at 10:28 AM CDT.
